

## Changes to Letter of Offer for the provision of Alipay Merchant Services

- 1. All references to Alipay are changed to Alipay+.
- 2. The text under "Approved foreign currency" is deleted and replaced with:

  For the purposes of clause 9.1(k) of the Master Terms, we confirm that any foreign currency permitted by Alipay+
  is designated as an approved foreign currency that you are authorised to use for Alipay+ transactions.
- 3. Appendix 1 is deleted and replaced with:

## **Appendix 1: Alipay+ Terms & Conditions**

- Refunds
- a. Refunds can be processed up to 365 days from the date of the original purchase Transaction. The refund amount cannot exceed the value of the original purchase Transaction and will be processed with the same exchange rate as the original purchase Transaction.
- b. You must ensure that your refund policy advises Alipay+ Users of the time limitation on applying for a refund e.q. whether that is 365 days or less from the date of the transaction.
- 2. Alipay+ Payment Policies
- a. You must not charge a surcharge fee to recover your Alipay+ Merchant Service Fee from the User.
- 3. Storage of Transaction Information
- a. You must retain records for each Transaction for the period of 5 years after completion of the Transaction and make them available to Alipay+ within 14 days of request from us. If Transaction Evidence is required by any regulatory or governmental agencies, you will provide us with Transaction Evidence within 5 working days of request from us.
- 4. Anti-Money Laundering requirements
- a. You agree to co-operate with BNZ in the event of any reasonable due diligence Alipay+ conducts on BNZ's anti-money laundering, counter-terrorism financing and sanctions policies and procedures.
- 5. Intellectual Property
- a. You have during the term of this Merchant Agreement, a license to use the relevant intellectual property rights in the Alipay+ Services, the Alipay+ Platform and the Alipay+ branding and logo solely for using the Alipay+ Services in accordance with this Agreement. Such license is non-exclusive, non-sublicensable and non-transferrable, and may be modified or revoked any time during the term of this Merchant Agreement. You shall be permitted to use Alipay+ branding and logo solely as required for using or promoting the Alipay+ Services.
- b. You agree that the licenses granted under this clause and your use of such intellectual property rights under this Merchant Agreement will not confer any proprietary right, and you agree to take reasonable care to protect all such intellectual property rights from infringement or damage and cease all use of such intellectual property rights immediately upon termination of this Merchant Agreement.
- c. The parties agree that there is no intention to create new intellectual property rights under this Merchant Agreement. If new intellectual property rights are created, the parties will negotiate in good faith to agree ownership and licensing rights in respect of such intellectual property.
- d. You grant a licence in favour of BNZ, Alipay+, it's Affiliates and/or the Payment Method Provider, the right to use your intellectual property on Alipay+'s, its Affiliates' or Payment Method Provider's website, wallet application and marketing and promotional materials, for the purpose of identifying BNZ or you as a user of Alipay+ Services.

For the purposes of the above the following words have the following meanings:

Affiliate	<ul> <li>i. a director, officer, partner, member, manager, executor or trustee of such person; and</li> <li>ii. any person directly or indirectly controlling, controlled by, or under common control with, that person.</li> <li>For the purposes of this definition, "control", "controlling" and "controlled" mean having the right to elect a majority of the board of directors or other comparable body responsible for the management and direction of a person by contract, by virtue of share ownership or otherwise.</li> </ul>
Alipay+	means Alipay Singapore E-Commerce Private Limited, a company incorporated in Singapore
Alipay+ Platform	means the payment processing system developed by Alipay+.
Alipay+ Services	means the following services:  i. electronic payment processing for Transactions via the Alipay+ Platform;  ii. reconciliation and settlement of Transactions with BNZ; and  iii. other related services and ongoing technical support in connection with any of the above.
Applicable Law	means any law, regulation, rule, requirements, judgment, decree, order or directive, including without limitation, any global, federal, country, state or local laws, rules and regulations and including those issued by governmental or regulatory authorities having jurisdiction over Alipay+ or BNZ, that are applicable to Alipay+ or BNZ or its business or which Alipay+ or BNZ is otherwise subject to.
Payment	means the transfer of a Transaction Value from a User to you which is routed, cleared and settled through Alipay+ Services.
Payment Method	means a product issued by a Payment Method Provider to a User (such as an electronic wallet) which allows that User to make a payment to a merchant which the merchant receives through the use of, or in reliance on, Alipay+ Services.
Payment Method Provider	means a person in its capacity as a payment method provider where it issues a Payment Method to a User, enters into a user agreement with a User or processes a Payment for a User.
Product	means all goods, products, services and/or items that you make available for sale to any person, including Alipay+ Users.
Transaction	means the transaction between you and a User in respect of goods or services made in person at your store, which gives rise to a Payment.
Transaction Evidence	means such evidence as Alipay+ reasonably requires, including the names and prices of the Product(s) to which the disputed Payment relates, together with relevant proof that the Product(s) have been properly delivered or rendered to the User, and, without limitation, video footage (e.g. CCTV), Transaction receipt and the name and contact information of the User who made Payment for the Product (if collected by you), the provision of which shall always be subject to Applicable Law.
User	means a person who has obtained a Payment Method from a Payment Method Provider.
