
Description of this Fund

The International Equity Fund invests in international equities primarily in developed markets, with the ability to invest to a lesser extent in emerging market countries. It aims to provide a gross return in excess of its benchmark index, over the long term.

What are the risks of investing?

Risk indicator¹ for the International Equity Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down (volatility). A higher risk generally means higher potential returns over time, but more ups and downs along the way.




Example of how this applies to an investor

John had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, John received a return after Fund charges were deducted of \$2,153.00 (that is 21.53% of his initial \$10,000). John also paid \$0.00 in other charges. This gives John a total return of \$2,153.00 for the year.


This shows the types of assets the Fund invests in.

Currency hedging

Currency hedging may be used to mitigate the impact of currency movements on investments in foreign securities. As at the date of this Fund Update, the Manager applies the following currency hedging ratio:

• 70% of fund's international equities exposure

Notes

- 1. Because the risk indicator is calculated using the past 5 years' worth of returns, in periods of high return volatility the risk indicator is more susceptible to change from time to time.
