
Description of this Fund

The Growth Fund invests primarily in growth assets which generally have higher levels of risk with the potential for higher returns. It also has an allocation to income assets which generally have lower levels of risk and return. It aims to achieve higher returns over the long term.

What are the risks of investing?

Risk indicator¹ for the Growth Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down (volatility). A higher risk generally means higher potential returns over time, but more ups and downs along the way.


Example of how this applies to an investor

John had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year John received a return after Fund charges and GST were deducted of \$1,245.00 (that is 12.45% of his initial \$10,000). John also paid \$0.00 in other charges. This gives John a total return of \$1,245.00 for the year.

This shows the types of assets the Fund invests in.


Actual investment mix*

Currency hedging

Currency hedging may be used to mitigate the impact of currency movements on investments in foreign securities. As at 30 June 2018, currency hedging is as follows:

- International fixed interest 100% hedged to NZD
- International equities 40% hedged to NZD (target 50%)

• Australian equities within the Australasian equity investment mix – 42% hedged to NZD (range between 0 - 100%)

Notes

- 1. As the Fund has not been in existence for 5 years, a combination of actual returns and market index returns have been used to calculate the Fund's risk indicator. The risk indicator, therefore, may provide a less reliable indicator of the potential future volatility of the Fund.
