
Description of this Fund

The Moderate Fund invests primarily in income assets which generally have lower levels of risk and return. It also has an allocation to growth assets which generally have higher levels of risk with the potential for higher returns. It aims to achieve moderate returns over the medium term.

What are the risks of investing?

Risk indicator¹ for the Moderate Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down (volatility). A higher risk generally means higher potential returns over time, but more ups and downs along the way.


Example of how this applies to an investor²

John had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year John received a return after Fund charges were deducted of \$578.00 (that is 5.78% of his initial \$10,000). John also paid \$0.00 in other charges. This gives John a total return of \$578.00 for the year.

This shows the types of assets the Fund invests in.


Actual investment mix*

Currency hedging

Currency hedging may be used to mitigate the impact of currency movements on investments in foreign securities. As at 31 March 2019, currency hedging is as follows:

- International fixed interest 100% hedged to NZD
- International equities 40% hedged to NZD (target 50%)
- Australian equities within the Australasian equity investment mix 46% hedged to NZD (range between 0 100%)

Notes

- 1. As the Fund has not been in existence for 5 years, a combination of actual returns and market index returns have been used to calculate the Fund's risk indicator. The risk indicator, therefore, may provide a less reliable indicator of the potential future volatility of the Fund.
- 2. Because this Fund started operating on 29 March 2018, the Fund's market index return for the full year referred to in the section "How has the Fund performed" has been used in this example rather than the actual Fund return (which only exists for a partial year). The market index return referred to in the section "How has the Fund performed?" reflects no deductions for Fund charges, and so has been adjusted for the purposes of this example (inclusive of GST). This example generally illustrates how fees may affect an investor holding \$10,000 in the Fund for a year. It does not reflect the impact of buy/sell spreads that may apply when a person makes a new or additional contribution into the Fund or withdraws from the Fund.
