



## Fund Update

### Fund Update for period to 30 June 2018

This Fund Update was first made publicly available on 23 July 2018.

#### What is the purpose of this update?

This document tells you how the Moderate Fund (Fund) has performed and what fees were charged. The document will help you to compare the Fund with other funds. BNZ Investment Services Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.


#### Description of this Fund

The Moderate Fund invests primarily in income assets which generally have lower levels of risk and return. It also has an allocation to growth assets which generally have higher levels of risk with the potential for higher returns. It aims to achieve moderate returns over the medium term.

#### What are the risks of investing?

##### Risk indicator<sup>1</sup> for the Moderate Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down (volatility). A higher risk generally means higher potential returns over time, but more ups and downs along the way.

## What fees are investors charged?


## Example of how this applies to an investor

John had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year John received a return after Fund charges and GST were deducted of \$621.00 (that is 6.21% of his initial \$10,000). John also paid \$0.00 in other charges. This gives John a total return of \$621.00 for the year.

This shows the types of assets the Fund invests in.


### Actual investment mix\*

## Currency hedging

Currency hedging may be used to mitigate the impact of currency movements on investments in foreign securities. As at 30 June 2018, currency hedging is as follows:

- International fixed interest – 100% hedged to NZD
- International equities – 40% hedged to NZD (target 50%)
- Australian equities within the Australasian equity investment mix – 42% hedged to NZD (range between 0 - 100%)

## Notes

1. As the Fund has not been in existence for 5 years, a combination of actual returns and market index returns have been used to calculate the Fund's risk indicator. The risk indicator, therefore, may provide a less reliable indicator of the potential future volatility of the Fund.
2. The annual fund charges for the Fund include a best estimate of 1) the costs and expenses charged by the underlying investment funds (other than the management fees of the underlying investment fund managers) into which the Fund invests; and 2) expenses which BNZ Investment Services Limited (as Manager) and The New Zealand Guardian Trust Company Limited (as Supervisor) may charge the Fund as permitted by the Governing Document. These estimates are based on the costs and expenses disclosed in the underlying investment fund offer documents, or where such offer documents do not exist, verification from the relevant underlying investment manager.
