What is the purpose of this update?

This document tells you how the Conservative Fund (Fund) has performed and what fees were charged. The document will help you to compare the Fund with other funds. BNZ Investment Services Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

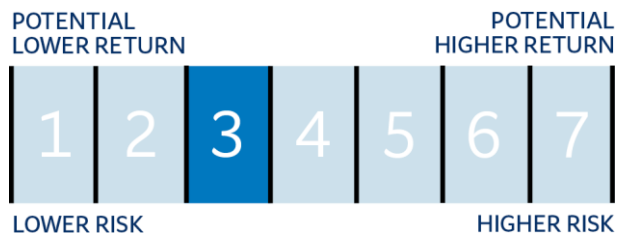
Description of this Fund

The Conservative Fund invests mostly in income assets which generally have lower levels of risk and return. It has a modest allocation to growth assets which generally have higher levels of risk with the potential for higher returns. It aims to achieve relatively stable returns over the short to medium term.

What are the risks of investing?

Risk indicator for the Conservative Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down (volatility). A higher risk generally means higher potential returns over time, but more ups and downs along the way.

To help you clarify your own attitude to risk, you can seek financial advice or work out your risk profile at bnz.co.nz/whatfund. Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.

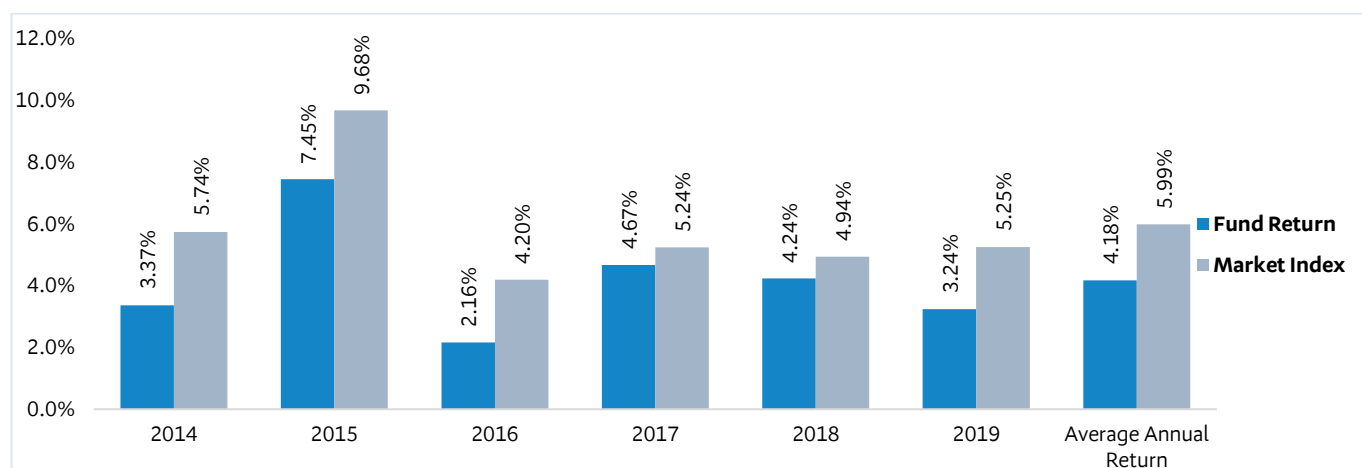

How has the Fund performed?

The graph shows the return after Fund charges and tax for each year ending 31 March since the Fund started. The last bar shows the average annual return since the Fund started, up to 30 June 2019.

* The total management and administration fee for the Fund was reduced to 0.50% effective 13 May 2019. As a result, the total fund

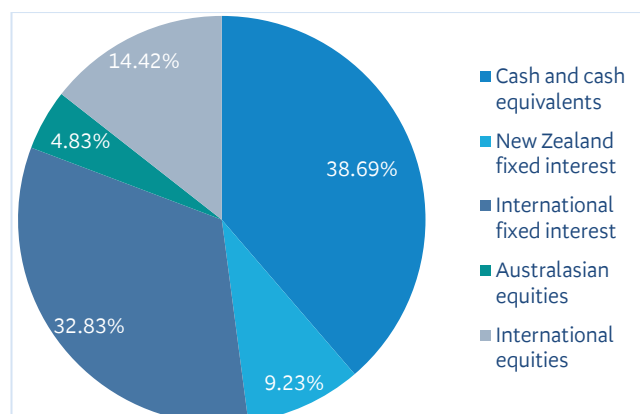
Example of how this applies to an investor

John had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, John received a return after Fund charges were deducted of \$373.00 (that is 3.73% of his initial \$10,000). John also paid \$23.40 in other charges. This gives John a total return of \$349.60 for the year.

What does the Fund invest in?

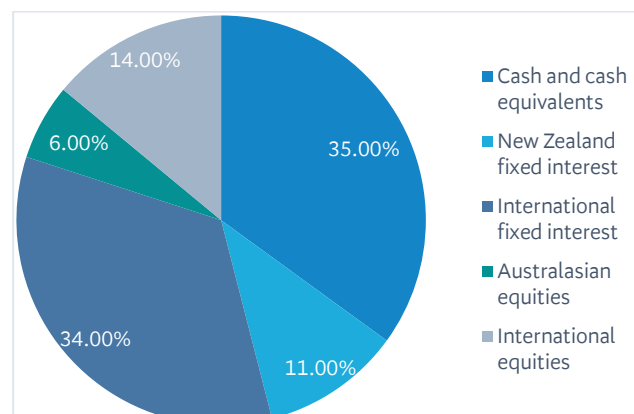
This shows the types of assets the Fund invests in.

Currency hedging

Currency hedging may be used to mitigate the impact of currency movements on investments in foreign securities. As at 30 June 2019, currency hedging is as follows:

- International fixed interest – 100% hedged to NZD
- International equities – 40% hedged to NZD (target 50%)
- Australian equities within the Australasian equity investment mix – 58% hedged to NZD (range between 0 - 100%)

Notes

1. Member fees in the BNZ KiwiSaver Scheme were \$1.95 per member per month and were charged proportionately across funds where a member invests in more than one BNZ KiwiSaver Scheme fund. The member fee was removed effective 1 May 2019.
2. The actual investment mix allocations have been calculated including cash and cash equivalents held at our investment managers for operational and hedging purposes within the asset class to which they apply.
3. Cash and cash equivalents held at our investment managers for operational and hedging purposes are excluded from the top 10 investments.
