Fund Update for period to 31 March 2017

This Fund Update was first made publicly available on 5 May 2017.

What is the purpose of this update?

This document tells you how the Cash Fund has performed and what fees were charged. The document will help you to compare the Fund with other funds. BNZ Investment Services Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this Fund

The Cash Fund invests in assets which have lower risks and returns, including New Zealand short term cash securities (on call bank deposits) and cash equivalent securities (bonds, bills and floating rate notes with maturities less than 365 days). It aims to achieve stable returns.

What are the risks of investing?

Risk indicator for the Cash Fund¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down (volatility). A higher risk generally

means higher potential returns over time, but more ups and downs along the way.

To help you clarify your own attitude to risk, you can seek financial advice or work out your risk profile at bnz.co.nz/riskprofile. Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.

While risk indicators are usually relatively stable, they do shift from time to time. The risk indicator will continue to be updated in future Fund Updates.

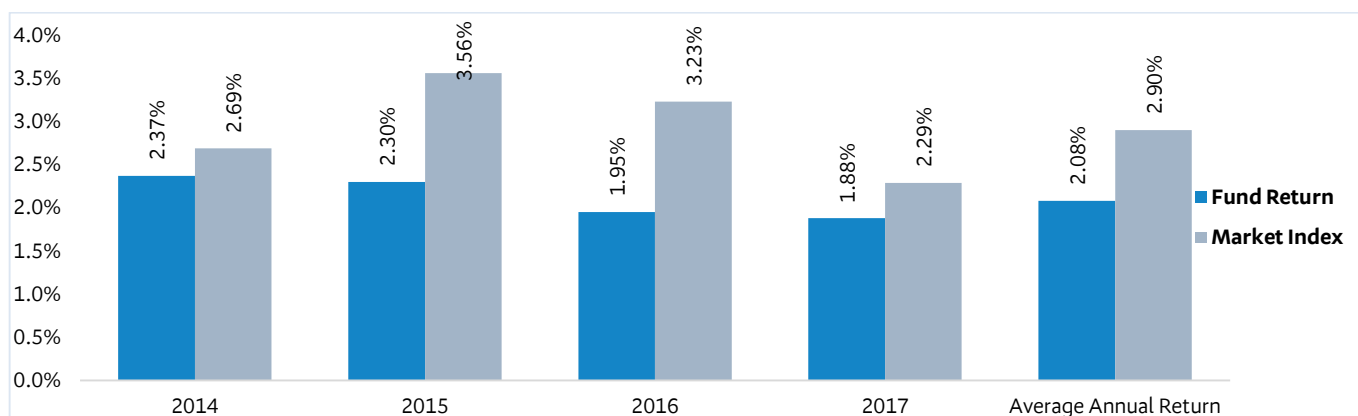

How has the Fund performed?

The graph shows the return after Fund charges and tax for each year ending 31 March since the Fund started. The last bar shows the average annual return since the Fund started, up to 31 March 2017.

Investors are charged member fees of \$1.95 per month (\$23.40 p.a.).

Small differences in fees and charges can have a big impact on your investment over the long term.

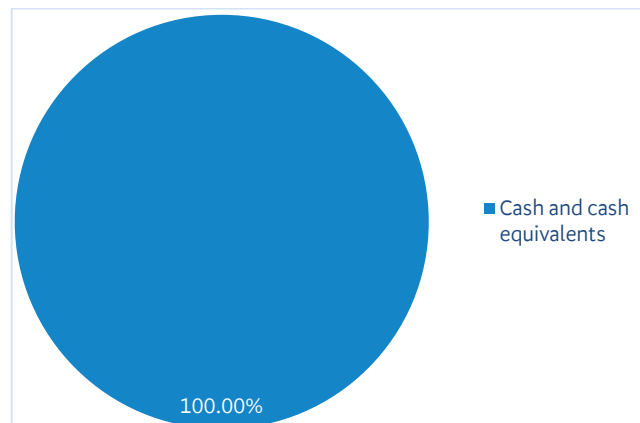
Example of how this applies to an investor

John had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, John received a return after Fund charges were deducted of \$188.00 (that is 1.88% of his initial \$10,000). John also paid \$23.40 in other charges. This gives John a total return of \$164.60 for the year.

Notes

1. As the Fund has not been in existence for 5 years, a combination of actual returns and market index returns have been used to calculate the Fund's risk indicator. The risk indicator, therefore, may provide a less reliable indicator of the potential future volatility of the Fund.
2. Member fees in the BNZ KiwiSaver Scheme are \$1.95 per member per month and are charged proportionately across funds where a member invests in more than one BNZ KiwiSaver Scheme fund.
