
Description of this Fund

The Conservative Fund invests primarily in income assets which have lower levels of risks and returns. It has a small allocation to growth assets which have higher risks and returns. It aims to achieve relatively stable returns over the medium term.

What are the risks of investing?

Risk indicator for the Conservative Fund¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down (volatility). A higher risk generally

means higher potential returns over time, but more ups and downs along the way.


How has the Fund performed?

The market index return is based on a composite index made up of the benchmark indices. The composition of this index has changed since the previous Fund Update for this Fund.

The composition of the index has changed due to the replacement of the underlying manager for the International Equities component of the Fund. BNZ Investment Services Limited considers the new market index to be appropriate to reflect the change to this component. The graph shows the return after Fund charges and tax for each year ending 31 March since the Fund started. The last bar shows the average annual return since the Fund started, up to 30 June 2017.


Example of how this applies to an investor

John had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, John received a return after Fund charges were deducted of \$477.00 (that is 4.77% of his initial \$10,000). John also paid \$23.40 in other charges. This gives John a total return of \$453.60 for the year.
