Fund Update For quarter ending 30 June 2018

This Fund Update was first made publicly available on 23 July 2018.

What is the purpose of this update?

This document tells you how the First Home Buyer Fund (Fund) has performed and what fees were charged. The document will help you to compare the Fund with other funds. BNZ Investment Services Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this Fund

The First Home Buyer Fund invests primarily in income assets which generally have lower levels of risk and return. It has an allocation to growth assets which generally have higher levels of risk with the potential for higher returns. It aims to achieve relatively stable returns over the short to medium term.

What are the risks of investing?

Risk indicator¹ for the First Home Buyer Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down (volatility). A higher risk generally means higher potential returns over time, but more ups and downs along the way.



How has the Fund performed?

Annual return graph



The graph shows the return after Fund charges and tax for each year ending 31 March since the Fund started. The last bar shows the average annual return since the Fund started, up to 30 June 2018.

What fees are investors charged?

Investors are charged member fees of \$1.95 per month (\$23.40 p.a.). No GST is currently payable on BNZ KiwiSaver Scheme charges above. Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds). Investors are not currently charged individual actions fees.



Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

John had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, John received a return after Fund charges were deducted of \$352.00 (that is 3.52% of his initial \$10,000). John also paid \$23.40 in other charges. This gives John a total return of \$328.60 for the year. This shows the types of assets the Fund invests in.

Currency hedging

Currency hedging may be used to mitigate the impact of currency movements on investments in foreign securities. As at 30 June 2018, currency hedging is as follows:

- International fixed interest 100% hedged to NZD
- International equities 40% hedged to NZD (target 50%)
- Australian equities within the Australasian equity investment mix 42% hedged to NZD (range between 0 100%)




