What is the purpose of this statement?

This statement provides key information about the BNZ KiwiSaver Scheme Moderate Fund. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

Description of the fund

The Moderate Fund may suit you if you have a medium investment timeframe, and you are prepared to accept some investment risk to achieve returns which may be higher, over the medium term, than funds with a higher investment in income assets.

The Moderate Fund will principally invest in cash and fixed income investments, with some exposure to growth assets including New Zealand and international shares.



Members were also charged **membership fees**⁴ of **\$23.40** over the year⁵.


Example of how this applies to a member

John had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, John received a return after fund fees and tax were deducted of \$148.00 (that's 1.48% of his initial \$10,000). John also paid \$23.40 in membership fees. This gives John a total return of \$124.60 for the year.

Notes

- 1. Returns in this statement are after tax at the highest prescribed investor rate (PIR) of tax for an individual New Zealand resident. Your tax rate may be lower.
- 2. Fund fees are fees charged as a percentage of a member's interest in the fund (i.e. as a percentage of their KiwiSaver account balance).
- 3. As required by the KiwiSaver (Periodic Disclosure) Regulations 2013, the **fund fees** shown in this statement are based on the average month end net asset value of the fund. This is different to how the fund's **annual management fee** is charged. The fund's **annual management fee** is charged at 0.90% per annum of the average daily gross asset value of the fund.
- 4. Membership fees are the fixed dollar charges for membership in the KiwiSaver scheme.
- 5. **Membership fees** in the BNZ KiwiSaver Scheme are \$1.95 per member per month (\$23.40 per annum) and are charged proportionately across funds where a member invests in more than one BNZ KiwiSaver Scheme fund.
