1. Details of scheme

- > The name of the scheme is BNZ Private Wealth Series ('Scheme').
- > The Scheme type is a Managed Investment Scheme under the Financial Markets Conduct Act 2013.
- > The Manager of the Scheme is BNZ Investment Services Limited.
- > The Supervisor of the Scheme is The New Zealand Guardian Trust Company Limited.
- > The latest Product Disclosure Statement (PDS) for the Scheme is dated 5 March 2018 and is open for applications.
- > The latest Fund Update for each of the Funds in the Scheme is available to 30 June 2018.
- > The latest Financial Statement and Auditors Report for the Scheme have been lodged with the Registrar and cover the financial year from 1 April 2017 to 31 March 2018. These were lodged on 17 July 2018.

3. Changes relating to the scheme

Statement of investment Policy and Objectives (SIPO):

The SIPO for the Scheme was updated in September 2017 to reflect the introduction of active asset allocation with respect to the currency management of the Private Wealth Series (PWS) International Equity Fund.

The SIPO was also updated in March 2018 to reflect benchmark changes to the PWS NZ Fixed Interest Fund, and changes to the target investment mix for all Funds except the Cash Fund.

Related party transactions:

There have been no changes to the nature or scale of related party transactions. All related party transactions for the year to 31 March 2018 were on arms-length terms.

Investment manager changes:

Following our annual review process, there were manager changes to two of the Funds within the Scheme:

Harbour Asset Management (Harbour) was appointed as manager of the PWS NZ Fixed Interest Fund on 19 March 2018, replacing Nikko Asset Management (Nikko). AMP was retained to manage the Fund along with Harbour, with each managing approximately 50% of the Fund.

Mint Asset Management (Mint) was appointed as manager of the PWS Australasian Equity Fund, alongside Nikko. Both Mint and Nikko manage approximately 50% of the Fund. Prior to 19 March 2018, Nikko was the sole manager of the Fund.

Product Disclosure Statement (PDS):

A replacement Private Wealth Series PDS was issued on 5 March 2018.

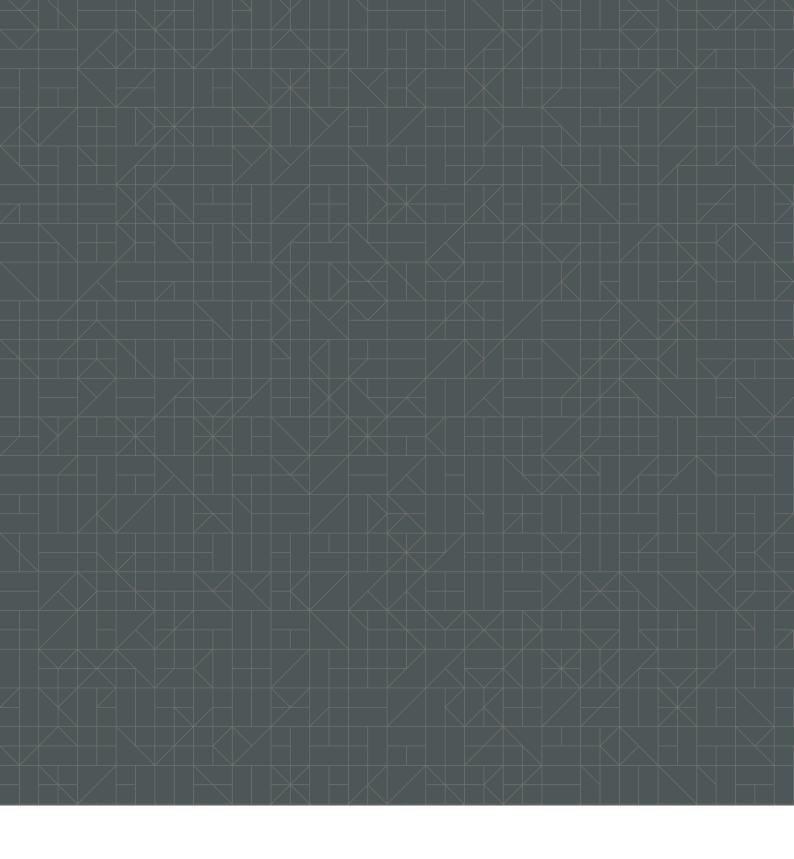
