#### What is the purpose of this update?

This document tells you how the Australasian Equity Fund (Fund) has performed and what fees were charged. The document will help you to compare the Fund with other funds. BNZ Investment Services Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

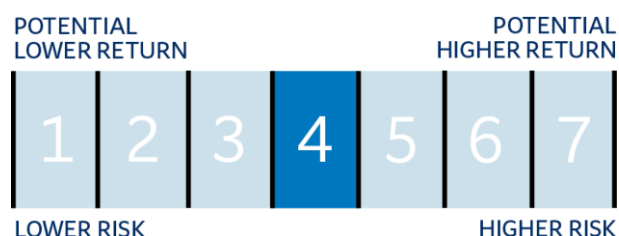
#### Description of this Fund

The Australasian Equity Fund provides an exposure to Australasian equities primarily listed on the New Zealand equity market. It aims to provide a gross return in excess of its benchmark index, over the long term.

#### What are the risks of investing?

Risk indicator<sup>1</sup> for the Australasian Equity Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down (volatility). A higher risk generally means higher potential returns over time, but more ups and downs along the way.

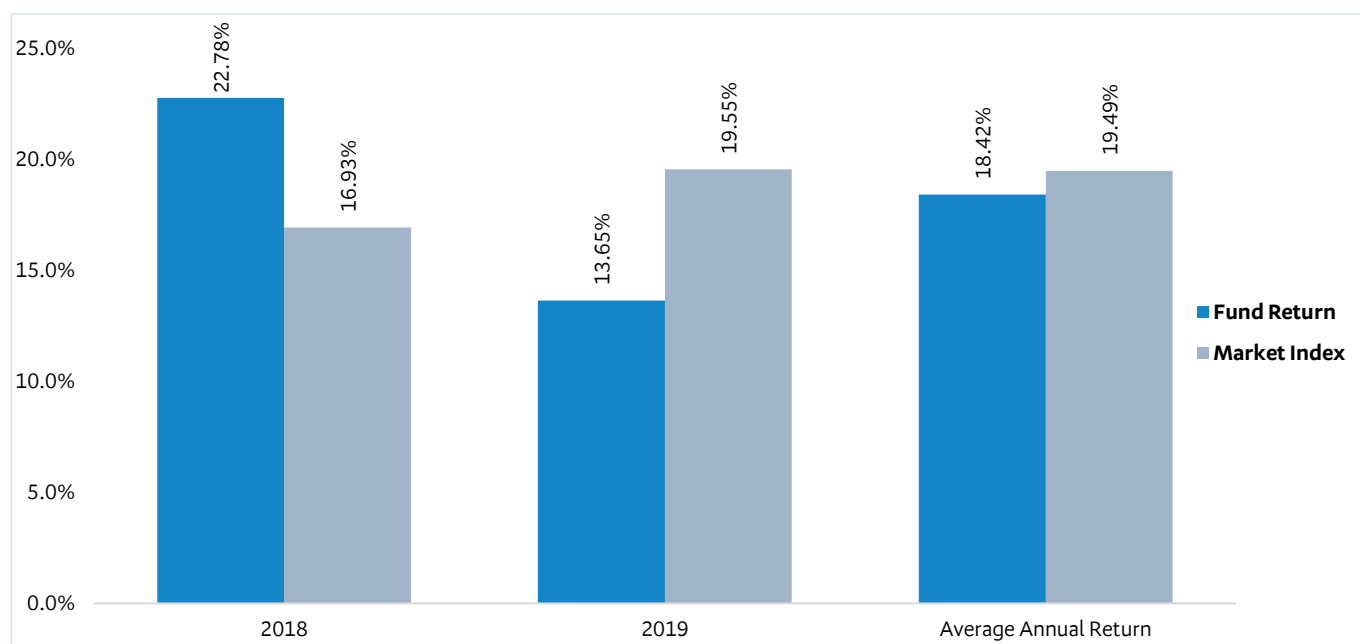
#### How has the Fund performed?

## Annual return graph



The graph shows the return after Fund charges and tax for each year ending 31 March since the Fund started. The last bar shows the average annual return since the Fund started, up to 31 December 2019.

**Important:** This does not tell you how the Fund will perform in the future.

Returns in this update are after tax at the highest prescribed investor rate (PIR) of tax for an individual New Zealand resident. Your tax may be lower.

Market index returns do not include Fund charges or deductions for tax.

Small differences in fees and charges can have a big impact on your investment over the long term.

## Example of how this applies to an investor

John had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, John received a return after Fund charges were deducted of \$2,726.00 (that is 27.26% of his initial \$10,000). John also paid \$0.00 in other charges. This gives John a total return of \$2,726.00 for the year.

## What fees are investors charged?

Investors in the Australasian Equity Fund are charged Fund charges. In the year to 31 March 2019 these were (excluding GST):

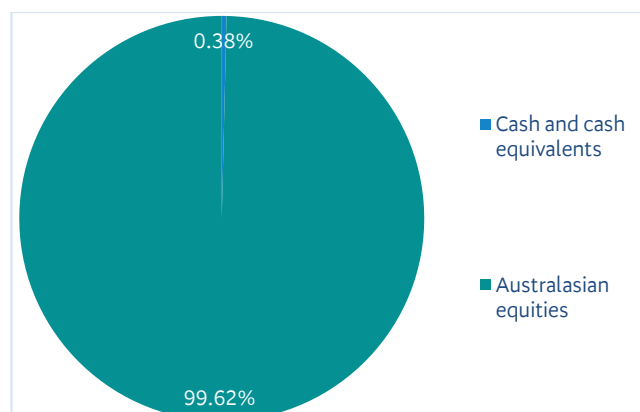

## What does the Fund invest in?

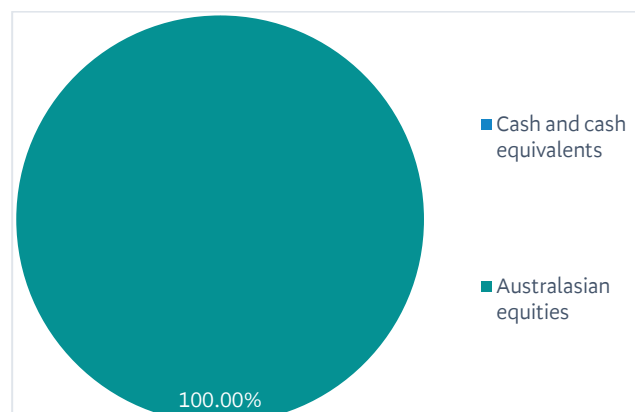
This shows the types of assets the Fund invests in.

## Currency hedging

Currency hedging may be used to mitigate the impact of currency movements on investments in foreign securities. As at the date of this Fund Update, the Manager applies the following currency hedging ratio:

- 100% of the fund's Australian equities exposure

## Notes

1. As the Fund has not been in existence for 5 years, a combination of actual returns and market index returns have been used to calculate the Fund's risk indicator. The risk indicator, therefore, may provide a less reliable indicator of the potential future volatility of the Fund.
2. The calculation of cash and cash equivalents within the actual investment mix allocation may include investor flows not yet unitised, liquidity cash and fund accruals. This may result in a higher allocation to cash and cash equivalents than is shown in the target investment mix.
3. Investor flows not yet unitised, unsettled trades, currency hedging gains (or losses) and any operating accruals are excluded from the Top 10 investments.
