## Fund Update

### For quarter ending 31 March 2019

#### What is the purpose of this update?

This document tells you how the International Equity Fund (Fund) has performed and what fees were charged. The document will help you to compare the Fund with other funds. BNZ Investment Services Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

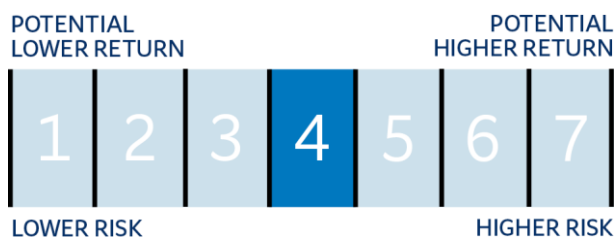
#### Description of this Fund

The International Equity Fund provides an exposure to international shares by primarily investing in a diversified portfolio of shares in developed markets, with the ability to invest to a lesser extent in emerging market countries. It aims to provide a gross return in excess of its benchmark index, over the long term.

#### What are the risks of investing?

##### Risk indicator<sup>1</sup> for the International Equity Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down (volatility). A higher risk generally means higher potential returns over time, but more ups and downs along the way.

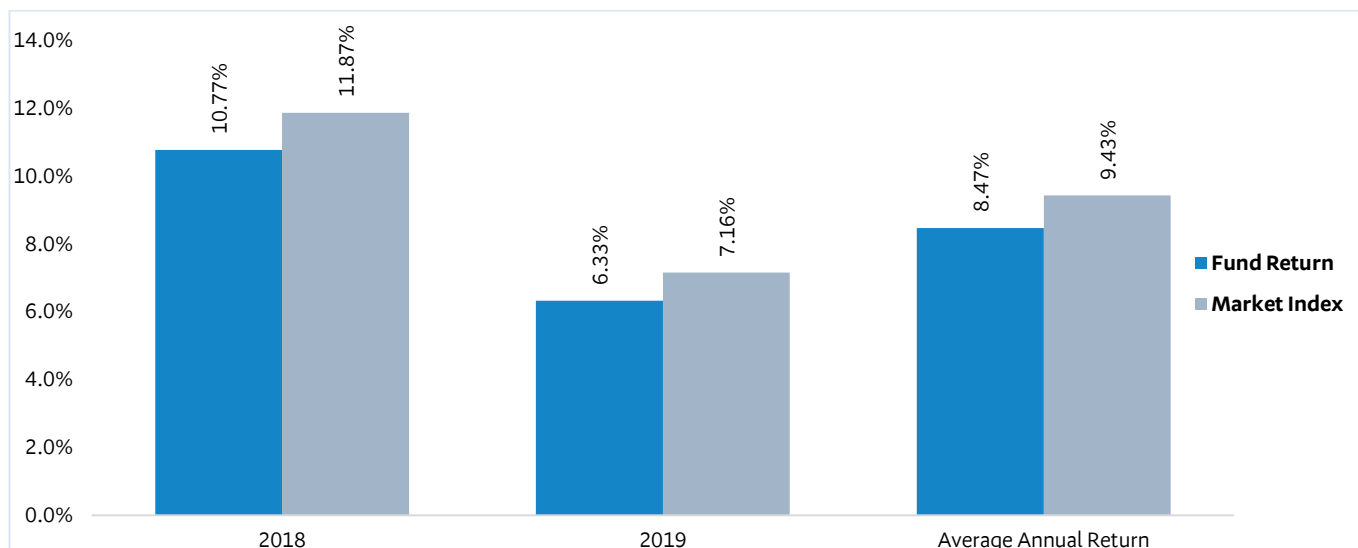

#### How has the Fund performed?

## Annual return graph



The graph shows the return after Fund charges and tax for each year ending 31 March since the Fund started. The last bar shows the average annual return since the Fund started, up to 31 March 2019.

**Important:** This does not tell you how the Fund will perform in the future.

Returns in this update are after tax at the highest prescribed investor rate (PIR) of tax for an individual New Zealand resident. Your tax may be lower.

Market index returns do not include Fund charges or deductions for tax.

Small differences in fees and charges can have a big impact on your investment over the long term.

### Example of how this applies to an investor

John had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, John received a return after Fund charges were deducted of \$633.00 (that is 6.33% of his initial \$10,000). John also paid \$0.00 in other charges. This gives John a total return of \$633.00 for the year.

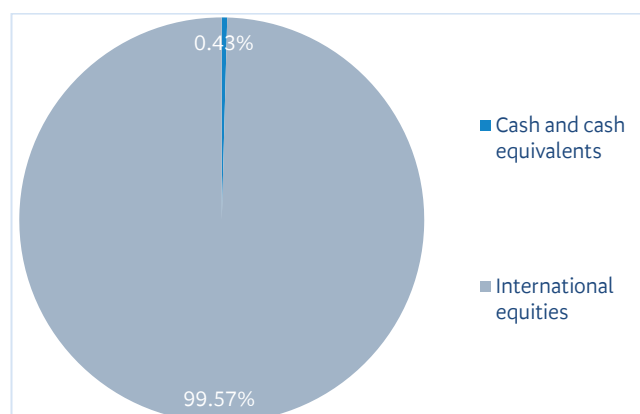
Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds). Investors are not currently charged individual actions fees.

This shows the types of assets the Fund invests in.

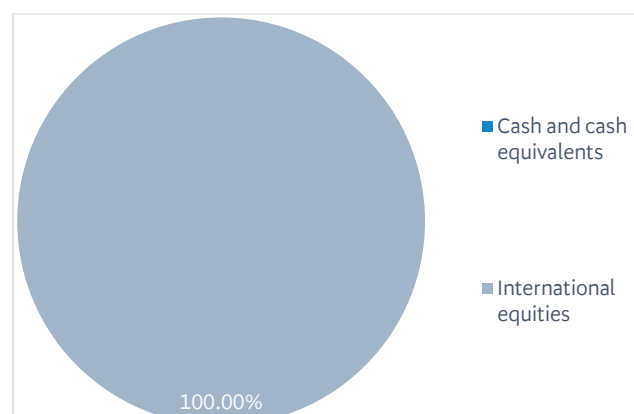
### Actual investment mix\*

## Currency hedging

Currency hedging may be used to mitigate the impact of currency movements on investments in foreign securities. As at 31 March 2019, currency hedging is as follows:

- International equities – 40% hedged to NZD (target 50%)

## Notes
